RIVER JAM APPLICATION

Complete the online River Jam Concert Series application at <https://www.ossiningchamber.org>

INSURANCE - VERY IMPORTANT - PLEASE READ CAREFULLY and YOU WILL NEED TO SUBMIT THESE TWO COMPLETED DOCUMENTS with your RiverJam application.

➤ **A current Certificate of Insurance in the amount of \$1,000,000 is required for all vendors. The Description of Operations/Locations/Vehicles section on the COI must include the following:**

The Town of Ossining, Village of Ossining, and the Greater Ossining Chamber of Commerce are named as additional insureds as per form number _____ ; copy attached.

➤ **In addition to the certificate of insurance named above, complete, sign and date the provided Ossining Vendor Insurance Agreement and return with your application.**

FOOD PERMITS

➤ Food vendors may obtain a temporary food permit by contacting the Westchester County Department of Health - Bureau of Public Health Protection Mount Kisco Central Office, 25 Moore Avenue, Mount Kisco, NY 10549

➤ Food Trucks are required to have a current Westchester County Food License.

CHECKLIST

- Vendor Application online completed
 - Valid Westchester County Food Permit
 - Certificate of Insurance - with required verbiage outlined in "insurance" above → Ossining Vendor Insurance Agreement - completed by vendor as outlined in "insurance" above
 - Payment-Greater Ossining Chamber of Commerce by credit card
- Note: Dates are not reserved until required documents and payments are received.

ARRIVAL, SETUP & TAKEDOWN

- Setup begins at 4:30 pm-Louis Engel Park, 25 Westerly Road, Ossining, NY 10562
- Vendors are required to stay until the conclusion of the event.
- Concert committee does not supply tables, chairs, tents, generators, or water. ➤ Let us know on the vendor application if electricity is needed. Bring a 100 foot extension cord.
- Safety is important and your tent/canopy is required to be securely anchored. This will prevent your tent from becoming airborne in the event of high winds.
- Signage with a menu and pricing is required.

OSSINING'S GREEN AGENDA

- Ossining is committed to a green agenda and preserving the environment. ➤ Vendors are required to use appropriate compostable serving containers. ➤ All trash and cooking oils must be taken away upon vendor departure. **DO NOT DUMP OILS ON THE GROUND or IN THE GRASS.**

INCLEMENT WEATHER

- At the discretion of the River Jam Concert Committee an event may be moved to a rain date in the event of inclement weather. Vendors will be contacted as early as possible to avoid unnecessary travel. ➤ Arrangements should be made by each Vendor to staff your booth or truck on the rescheduled date.
